Unipres Corporation (Head Office: Yokohama-City, Kanagawa-Pref., President: Masanobu Yoshizawa) passed a resolution at a meeting of its Board of Directors on November 7, 2016, to establish a joint company in China, with UNIPRES (CHINA) CORPORATION, a consolidated subsidiary of the Company, and Dongfeng (Wuhan) Industrial Co., Ltd.

2. Reason for establishment of joint company

In the automobile industry, where car body weight reductions and high strength have recently advanced, the adoption of hot-stamped parts is expected to expand in addition to the application of high tensile strength steel by cold pressing.

While our two plants in Japan and the UK are now producing parts by hot stamping, the Company has decided to establish Dongfeng Unipres Hot Stamping Corporation to produce hot-stamped parts in order to meet the diverse needs of car makers in China jointly with Dongfeng (Wuhan)

Industrial Co., Ltd. In China, the businesses of car body products and transmission products are developing, and setting up this new business will lead to further business expansion. The joint venturer Dongfeng (Wuhan) Industrial Co., Ltd. is an automotive parts manufacturer affiliated with the Dongfeng Motor Group, which is a car maker representing China.

3. Impact on future business results

The establishment of a joint company is expected to have a negligible impact on consolidated business results for FY 2016 ending March 31, 2017.
